 - d. water, sewer, and drainage facilities to serve District East;
 - e. detention facilities to serve District East;
 - f. Effluent reuse matters, including Crestwater Homeowners Association effluent reuse project;
 - g. Westpark Lakes detention pond rehabilitation;
 - h. generators at District lift stations;

- deeds, easements, appraisals, consents to encroachment, encroachment agreements, assignments of capacity, requests for service, utility conveyances, out-of-district service agreements, utility commitment letters, and conveyances of District property;
